- Leading and contributing to policy development work with groups of ABI members including facilitating relevant committee meetings
- Reacting to developments in Government policy or the media that may impact on cyber, trade credit or pet insurance and helping insurers navigate these issues effectively.
- Advancing and monitoring the changing public policy issues that emerge as the UK cyber insurance market grows and develops, bringing increased political and regulatory attention.
- Developing policy positions in the context of Brexit and its effect on the cyber and specialist lines insurance markets
- Developing an effective industry response, both proactively and reactively, to reputational challenges facing the cyber and specialist insurance markets
- Building effective relationships with key stakeholders in ABI member firms based on a strong understanding of their commercial environment and the impact of regulation and legislation on their businesses and customer base.
- Building expertise on insurance innovation including InsureTech, digital information and 'the internet of things', and considering how they may benefit or present challenges to ABI members and the wider industry.

**We're looking for:**

While you don't need expertise in cyber and specialist lines, you will need strong policy development experience and be quick to develop policy understanding of complex issues.

You'll need to be confident with plenty of gravitas as you'll be going out to various events to champion the work of the ABI. Alongside this, you'll be good at digesting a variety of viewpoints and then building consensus between our members.



Experience and understanding of the financial services sector and of UK and EU legislative, political and regulatory environments would be preferable.
